Procedures for Operation Allies Welcome (OAW) I-94 Retrieval

Entry with Passports: Safe Haven guests who entered the United States with their passports are able to retrieve their I-94 on the I-94 website <u>https://i94.cbp.dhs.gov/I94/#/home</u>.

Entry without Passports: Safe Haven guests who do not have their passports can retrieve their I-94 information using the photo feature in the CBP One App.

Whether DHS or DOD employees, certain government contractors, or guests and their representatives (including Resettlement Agency partners), CBP One App can use the photo feature to access I-94 information on any mobile device. Using the app, the same mobile device can be used to retrieve the I-94 information for multiple individuals including family members or clients of Resettlement Agency partners.

The one-pager information sheets in the Appendix provide additional information that can be included in IOM travel bags to facilitate use of the photo (selfie) I-94 retrieval mechanism in the CBP One App.

For guest and Resettlement Agency partners:

- 1. Download CBP One App from Apple App Store or Google Play Store to mobile device
- 2. Create account or sign in with an email address using Login.gov
- 3. Who Are You Tap "Traveler" and then "Air" to begin
- 4. View I-94 Record Tap "Get most recent I-94"
- 5. Select "Search by Photo"
- 6. Take a photo to retrieve I-94 record
- To print the I-94 record The A-number from the I-94 record can be used to retrieve I-94 from website in place of passport number using the online instructions: <u>https://i94.cbp.dhs.gov/I94/#/home</u>.

<u>Constraints</u>: The full app has not been translated so individuals with limited English proficiency may need assistance. However, certain information has been translated into both Pashto and Dari with the OAW population in mind. CBP has made available one-page documents in Pashto and Dari regarding retrieving I-94 information, but the directions for the photo usage are still available in English only. Additionally, children 14 and under do not have photos attached to their records so will not be able to utilize the photo feature.

For USG employees and certain contractors:

Government employees (DHS/DOD) and certain contractors including International Organization for Migration (IOM) can retrieve OAW traveler information using the CBP One app including A-Number, H-Number, I-94 Record Number, and biographic information using the photo feature. There are also desktop capabilities for government users. Account creation through government accounts allows partners to confirm immigration information of the guest beyond I-94 information.

IOM specific instructions:

- 1. Download CBP One App from Apple App Store or Google Play Store to mobile device
- 2. Create account or sign in with work email address using Login.gov
- 3. Who Are You Tap "International Organization" and "Retrieve OAW Information"
- 4. **Take a photo** to retrieve guest information including a photo, biographical information, I-94 number, A number, and Hummingbird number.

You can access proof of your admission by tapping on "Get Most Recent I-94".



5. Photo Query Result A successful guery will retrieve your I-94 information.



3. Search by Photo

Operations Allies Welcome – If you do not have an Alien Registration Number - Select the "Search by Photo" button at the top (no biographical data is needed).



6. "Not Found" Result

Red will indicate that your I-94 information was not found. Tap on "Search by Biographical Data" or "Done" to return to the search page.

Red will indicate the individual is not found. Tap on "Check Next Traveler" to go to the next individual, or "Done' to return to the IO home screen.
